All heirs must sign a completed affidavit. If there is more than one heir, each heir must complete and sign this affidavit or sign a duplicate of this affidavit. If there are any material differences between duplicate affidavits, all of the affidavits will be rejected. If the heir is a minor, or is incapacitated, the parent or legal guardian must sign for the heir.

Submit this affidavit along with a Manufactured Home Ownership Application (Form 2952) and a valid county tax certification to the State of Oregon Building Codes Division or one of its county agents.
